The Bruhat Bangalore Mahanagara Palike (BBMP) invites Request for proposal from interested persons/firms for Conveyance and disposal of dismantled M.S. Angular sections of unauthorized hoardings stacked in Head office, BBMP premises

After login to Contractors, Please scroll down to the right side bottom to see List of Tenders, Please click there to find the details of NIT and download copy of the tender. The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee **for tender after registering in the portal**. The transaction fee is non-refundable if you wish to participate.

2. Tenders must be accompanied by **earnest money deposit of Rs. 12,500/= (Rs. Twelve thousand five hundred only)** which should be paid online through e-Procurement portal using any of the following payment modes:
 - a. Credit Card
 - b. Direct Debit
 - c. National Electronic Fund Transfer (NEFT)
 - d. Over the Counter (OTC).
3. Tender processing fee as per eproc-portal
4. Tenders must be electronically submitted (on-line through internet) with in the date and time published in e-procurement portal. 2. The tenderer should not be a defaulter to the BBMP by any means.
3. Terms used in this RFP document which have not been defined herein, shall have the meaning ascribed thereto in the draft Agreement.
4. Any Bidder, who has earlier been barred by BBMP from participating in BBMP projects, would not be eligible to submit a proposal, where the bar subsists on the proposal due date.

8. Proposal preparation Cost

The Bidder shall be responsible and shall pay for all the costs associated with the preparation of its proposal and its participation in the bidding process. BBMP will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the bidding process.

09. Project Inspections and Visit to the stacking yard at BBMP premises, N.R.Square.

1. Bidders may carry out the project inspection of the dismantled road medians during office hours at their cost.
 2. It would be deemed that by submitting the proposal for RFP, the Bidder has:

APPENDIX 'A'

General Stipulations:

1. Tenderers/Bidders may read carefully the tender notice and the following directions, the terms and conditions of the contract and sign the form of tender, appendixes, rates etc., after making appropriate entries wherever necessary.
2. All entries should be legible and in clear writing. Any correction made in the entries must be attested to by the signatory. Tenders containing erasures or alternations not so attested or written in illegible form are liable to be rejected. The offer for license fee quoted by the Tenderer/Bidder in the offer shall be firm and no downward revision will be allowed on any account.
3. Offer must be submitted in the e-proc portal.
4. Conditional Tenders, if any or Tenders not in accordance with the Terms and Conditions of this Tender notice will be rejected outright.
5. The following documents form part of the contract agreement.
 - a. Notice inviting the Tender/Offer.
 - b. The financial bid form
 - c. Appendix 'A' and 'B'
6. Tenderers/bidders are advised to visit the spot wherein the dismantled road medians are stacked in advance of the last date fixed for submission of the tender. A Tenderer/Bidder shall be deemed to have full knowledge of all the relevant documents, site etc. whether he inspects them or not.
7. Tenderers/Bidders or their authorised agents alone are allowed to participate in the Tenders. In the absence of authorisation letter no person shall claim the right to participate in the Tenders.
8. All charges on account of terminal or sales tax, service tax etc. and other duties on materials obtained by the successful tenderer for the purpose of conveyance and removal of dismantled road medians shall be borne by the Tenderer/Bidder himself.
9. In the event of the Tender/Bid being accepted, the successful tenderer should deposit the Security deposit of Rs. 3,00,000/- within 7 days from the date of receipt of acceptance letter in the form of DD in favour of The Commissioner, Bruhat Bangalore Mahanagara Palike.
10. The successful Tenderer/Bidder shall deposit the accepted amount within 7 days from the date of receipt of acceptance letter. Failure to do so will be treated as breach of tender conditions leading to forfeiture of the EMD and rejection of the bid.
11. The Commissioner shall have the right to accept or reject the Tender/Bid without assigning any reason.
12. Every Bid/Tender shall remain open for acceptance for a period of 120 days from the date of opening of the tenders and conducting of auction whichever is later.
13. Tender documents are not transferable.
14. All disputes that may arise during the period of contract should be got settled mutually and the decision of the Commissioner, BBMP is final.

16. The approximate quantity of M.S. angulars is 20 tons and the successful bidder has to produce the vehicle no's and the weigh bridge challan of removed material for each trip duly signed by the authorised signatory of the BBMP.

Appendix - B

TERMS AND CONDITIONS OF CONVEYANCE AND DISPOSAL OF DISMANTLED M.S. ANGULAR SECTIONS OF UNAUTHORIZED HOARDINGS STACKED IN HEAD OFFICE, BBMP PREMISES” .

01. Conveyance and disposal of dismantled M.S. Angular Sections of Unauthorized Hoardings Stacked in Head Office, BBMP Premises” is the sole responsibility of the successful bidder.
02. The successful bidder will be decided by the Highest amount quoted.
03. The Tenders can be a company/registered partnership firm/proprietary concern in the business of outdoor advertisement/construction of Bus-Shelters/street furniture/Road, signage's/public conveniences Development of Medians or any kind of Civil construction pertaining to outdoor advertisement. In case of a partnership firm at least one of the partners should fulfill the criteria.
04. The Financial Bid (financial bid form) should be submitted as per e-proc portal
 - a) The tenderer has to pay an E.M.D of Rs. 12,500/- (Rupees Twelve thousands five hundred only) as per e-proc portal. The E.M.D of the un-successful tenderer will be refunded 15 days after the acceptance of the tender. In case of the successful tender/bidder this EMD will be retained as security deposit.
05. The tenders shall be opened in the presence of the tenderers present on the scheduled date at the schedules time and venue.
 - a) The successful tenderer shall be liable to pay advertisement tax, cesses, service tax, and other statutory dues needed to be paid to Bruhat Bangalore Mahanagara Palike, Government or any other institution at rates prescribed from time to time.
